

Institutional Plan- PREA

The following plan will be followed in an effort to coordinate actions in response to an incident of sexual abuse:

First responders-

After following first responder duties, he/she will contact the on-call staff to report the incident.

The first responders will complete incident reports

Facility leadership-

The on-call staff will then contact the PREA coordinator

The facility director or case manager who is on-call will refer the victim to medical or mental health practitioner

Investigators-

The PREA coordinator will complete the administrative investigation

The PREA coordinator will follow up and coordinate with any outside criminal investigations
